School Enhancement Program: Many Israeli schools opened in response to the massive immigration from Russia to Israel, remain under-funded and lack basic educational standards. JOI established 25 computer centers serving 5,600 students with 400 computers, 24 science laboratories serving 4,500 students, 21 libraries, four English centers, and a dozen sports and music centers serving over 1,500 youths each. JOI provides academic equipment, teacher training, and curriculum consulting to augment teaching quality and ensure student achievement. and standarized student testing to augment teaching quality and ensure student achievement.

Lifeline: Thirty percent of Israel's elderly live exclusively on welfare, in severe financial distress. When specific emergencies arise, they simply do not have the money to cope. LifeLine partners with five municipal welfare agencies in Israel to provide the infrastructure, professional social workers, and professional assessments to provide the critical financial subsidies that they cannot offer to the most-needy elderly. Typically, LifeLine assists in areas that are not covered by the welfare system, such as dental work, hearing aids, eyeglasses, critical home repairs and medical transportation and medicine. LifeLine assists 10-12 emergency cases each month in five cities.

The social worker does a professional assessment of need and monthly prioritizes emergency situations of elderly that subsist on government welfare, whom the welfare agency is not able to cover, either because the need is not within their limited boundaries of support, or due to severely limited budgets. The municipal social worker ensures that assistance goes directly to managing specific emergency needs.

-Direct cash assistance to needy adults: JOI fulfills specific requests for assistance that are made via one of our staff or by one of several highly reliable and trusted volunteers that we have worked with for several years. These staff members or volunteers are required to track assistance offered to ensure that it is not misused. Cash assistance is very moderate (generally up to \$135) such that the degree of reliability is further ensured.
